The files are arranged in alphabetical order by file title, with the contents of the files arranged chronologically.

Mountbatten was born in 1900, the fourth and youngest child of Prince Louis of Battenberg and Princess Victoria of Hesse, one of Queen Victoria's granddaughters. He began his naval career at the Royal Naval College, Osborne, at the age of thirteen; he continued his education, first, at the Royal Naval College at Dartmouth, and then at the Royal Naval College at Keyham. In 1916 Mountbatten joined the battle cruiser HMS LION as a midshipman. He also served on HMS QUEEN ELIZABETH and HM Submarine K6. In October 1918 he joined HMS P31, taking part in escort and anti-submarine work. In 1919 Mountbatten interrupted his naval career to study at the University of Cambridge. He toured Australia and New Zealand, and India, with the Prince of Wales in 1920 and 1921. Following his marriage to Edwina Ashley in 1922, Mountbatten joined HMS REVENGE as a signals officer. He later served as captain of the destroyers HMS DARING and HMS WISHART. In July 1936 he joined the Naval Air Division, where he remained until he took command of HMS KELLY in 1939.
